Police Department Update (Joy)

148 tickets

- 21 impounded
- 2801 registrations
- 19 lock cuts

E-Bike / E-Scooter next steps (Aaron F)

- City now allowing Type 1 and 2 E-bikes on shared-use trails
- E-scooters
 - O Aaron F being contacted by five different scooter companies
 - O City Council hosting work session in early November about scooters
 - Currently state law forces scooters on sidewalks, considered a "toy"
 - o Council could write municipal code to allow them in bike lanes and on shared-use trails
 - Very difficult to use hand signals while riding e-scooters
 - Asking for feedback from group: PD can't enforce speed of bike because laser can cause damage to eyes, and radar can't pick up a bike (currently speed limit for bike on campus is 20 MPH), but impossible to enforce, but can enforce "reckless riding"
 - Will bring scooter to next meeting for people to try
 - o Regarding enforcement on CSU Campus:
 - PD, Facilities, PTS meet monthly and recommend tiered levels for speed limits on campus, along with high-traffic "mixing zones" with slower speed limit. Want CSU to be in lockstep with City, bit invite companies to come in before approval of City.

 Any change to enforcement will require approval from the Board of Governors
 - Comment from Jamie: in general, feedback from other areas who have recently allowed e-bikes on trails have gotten positive feedback
